The Wethersfield chapter of UNICO was founded in 1977. Our chapter consists of roughly 100 women and men that enjoy supporting our community and our Italian heritage. Since its founding, the chapter has provided close to **\$1 Million dollars in scholarships to Wethersfield residents!**

Our Annual Macaroni Dinner brings together hundreds of people to enjoy a traditional Italian Sunday dinner. This event is our prime fundraiser in support of our scholarship program. UNICO Wethersfield also sponsors an annual Golf Tournament, Bocce Tournament, Comedy Night and various other events.

During COVID our members raised over \$10,000.00 to feed Essential Workers/Frontline Workers. Our members raised thousands of dollars to provide \$25 gift certificates from local restaurants to be given to local needy residents - this initiative helped support local restaurants as the recipients used their gift cards. Through our "UNICO Eats" initiative, Wethersfield UNICO organized take out nights for local restaurants which resulted in over 150 extra meals being sold to keep our local restaurants in business.

The History of UNICO National

October 10, 1922 is a significant date in the history of the Italian-Americans as well as in the annals of American civic organizations. It was on that day, in Waterbury, Connecticut, that Dr. Anthony Vastola met with a group of business and professional citizens to form an organization that was to be different from the business, social, athletic, and mutual aid groups found in every city.

This organization would be different from others in that, for the first time, it would ask its members to make great sacrifices, not for personal material gain, but simply for the happiness found in service to others. That is why Dr. Vastola called the organization UNICO—unique—the only one of its kind in America, and its motto would be SERVICE ABOVE SELF. The initials were later to stand for Unity, Neighborliness, Integrity, Charity and Opportunity.

UNICO supports annual programs to commemorate and observe Columbus Day and to single out outstanding individuals with awards for community activity have been a source of commendable accomplishment. National awards scholarships of \$2500 four-year grants given annually on a national scale to worthy students. UNICO National is the only service organization to support the Mental Health program.
